

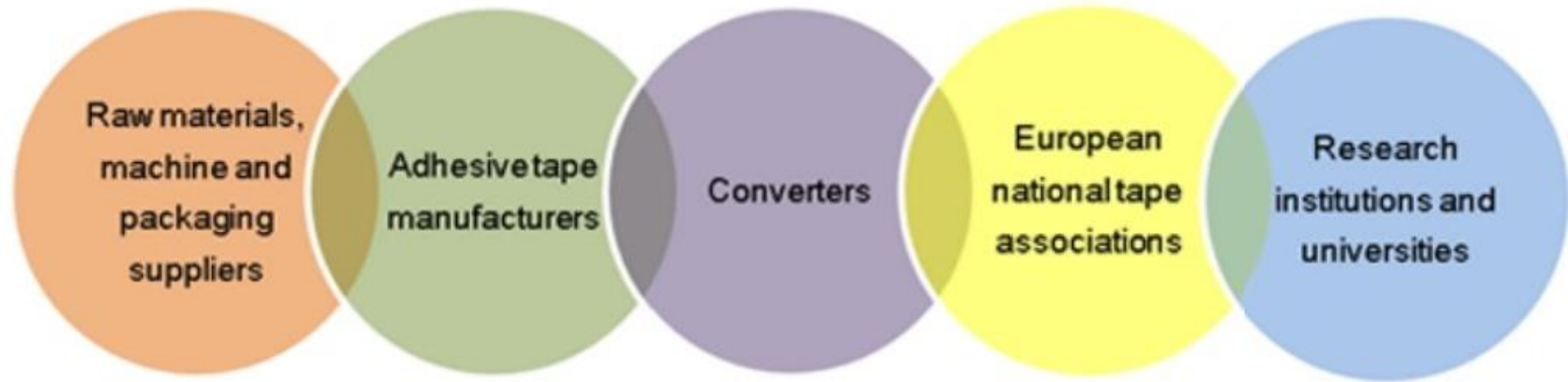

Afera is widely known and valued as the go-to community of the European tape industry for both Industry and non-Industry stakeholders.

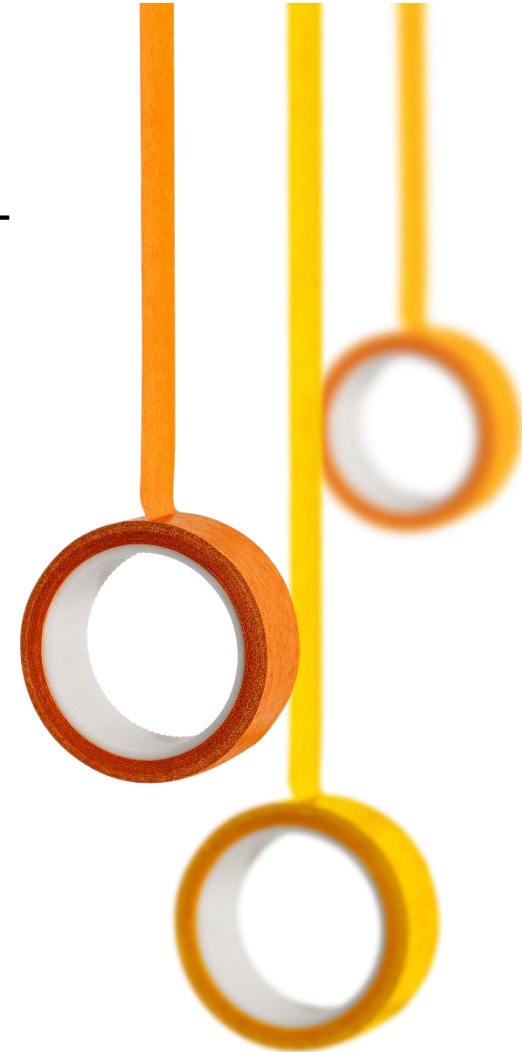
Stakeholders connect within Afera to address current and future key topics, which individual stakeholders cannot or prefer not to tackle themselves.

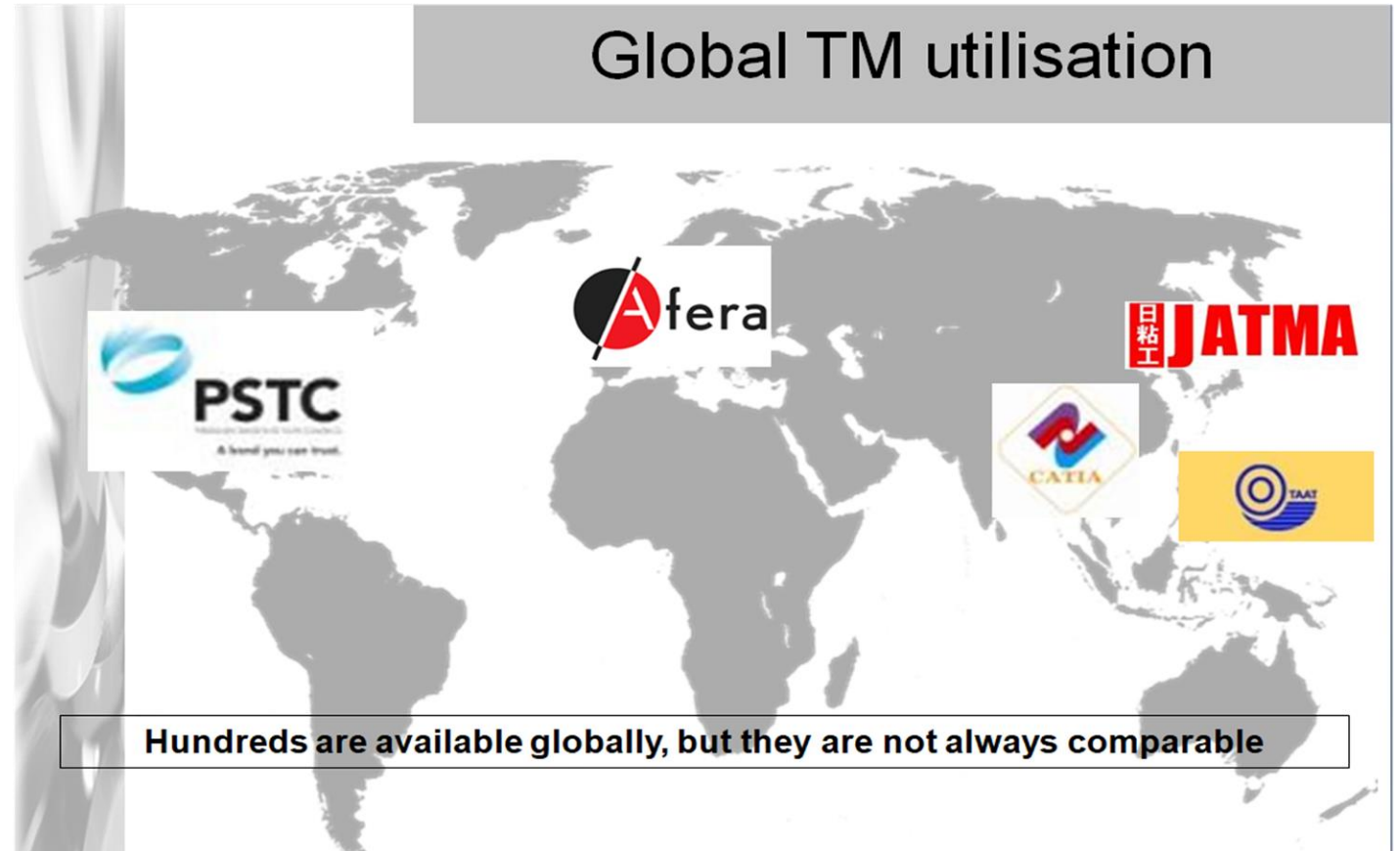

For tape manufacturers | Web-based

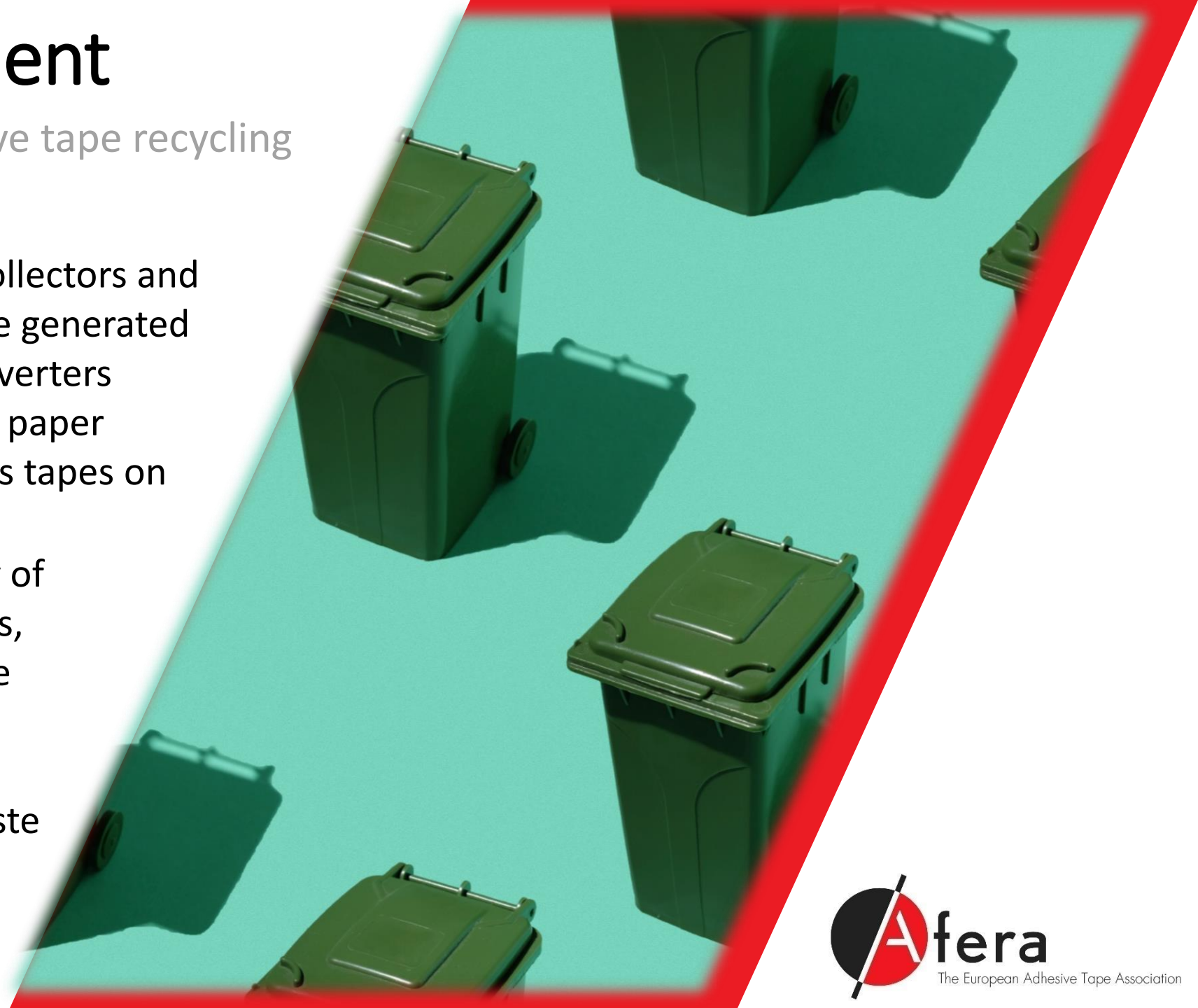
- Collaborating with German Adhesives Association IVK in developing a sector-wide tool for product carbon footprint calculation of both adhesives and adhesive tapes using a straightforward, harmonised, affordable method
- Scoping and building the adhesive and tape Tools with Members in a series of workshops, launching in 2024
- Made *by* the Industry *for* the Industry: It will become a standard, it will be required within the E.U., and it will help Members become more sustainable



Waste management

Develop release liner, adhesive tape recycling programmes

- Creating a database of waste collectors and recyclers compatible with waste generated by tape manufacturers and converters
- Afera position paper: Impact of paper release liner colour of adhesives tapes on material circularity
- Tackling fragmented availability of tape waste with tape converters, end-users and third-party waste management platforms
